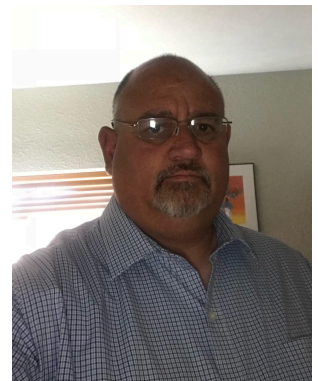
### Tim McGinnis
